Subject: Corrigendum – Tender for Empanelment of Maintenance Service Provider (MSP) for Repair/Overhaul of Twenty-Six (26) PW127M Engines – Extension of Last Date of Bid Submission and DTAA Clarification.

1. This Corrigendum is issued with reference to the Tender Ref. AAAL/PW127M/HoE/26/38 dated 12 February 2026 for "Empanelment of Maintenance Service Provider (MSP) to Repair or Overhaul Twenty-Six (26) PW127M Engines installed on Alliance Air's aircraft fleet."
2. In line with the request received from prospective bidders during the pre-bid meeting held on 27 February 2026, the **last date and time for submission of bids** is hereby extended by **fifteen (15) days** from the currently notified deadline.

3. All other terms and conditions of the tender remain unchanged.
4. **DTAA / Fees for Technical Services (FTS)**
 - Under the applicable Double Taxation Avoidance Agreement (DTAA) between India and the bidder's country, **Fees for Technical Services (FTS)** may be subject to withholding tax depending on the provisions of Article 12 of the respective treaty.
 - Accordingly, during the financial bid evaluation, any withholding tax impact applicable under the relevant DTAA will be treated as an additional cost and will be added to the bidder's quoted price for comparison purposes.
5. This Corrigendum shall form an integral part of the above-mentioned tender and shall be published on the Alliance Air website along with the tender document. Prospective bidders are advised to take note of the above and submit their bids accordingly.
