1. In case of 24 hours to 72 hours before departure, the cancellation charges will be as per the applicable fare rules. In case of 72 hours to 14 days before departure, the cancellation charges will be as per the applicable fare rules. In case of 14 days to 30 days before departure, the cancellation charges will be as per the applicable fare rules. In case of 30 days to 90 days before departure, the cancellation charges will be as per the applicable fare rules. In case of 90 days to 365 days before departure, the cancellation charges will be as per the applicable fare rules. In case of 365 days or more before departure, the cancellation charges will be as per the applicable fare rules.

Note:

1. All fare changes are applicable per person. In case of 'non-refundable', basic fares will be refunded.
2. In case of the Maximum Applicable Change and Cancellation Fees, the applicable fare rules will be applicable.
3. Governmental Fees: MSO rates will apply for change/cancellation of fare rules.
4. In case of flight cancellations.
5. Minimum baggage weight is as per the applicable fare rules.
6. Passengers should book to the point of origin by the first available carrier. Full amount to be refunded.
7. Other arrangements for the cancelled sector are made in the passenger's behalf of basic fare in the applicable fare rules.
8. The percentage is not taken for the ticketed destination as per applicable fare rules.
9. In case of non-refundable cancellations, the applicable fare rules will be applicable.
10. The applicable fare rules will be applicable for all sectors.
11. The applicable fare rules will be applicable for all sectors.
