- Where charges are applicable per coupon, in case of 'non-refundable', basic fare will be forfeited.
- In case of the lowest Available Change and difference of fare if any are applicable.
- Domestic taxes, RSR, will apply for change/cancellation/cancellation.
- In case of flight disruptions:
 - advance arrangements are made by the airline. Not Refund.
 - Passenger is taken back to the point of origin by the first available service - Full amount to be refunded.
- Over arrangement for the cancelled sector is made by the passenger's refund of basic fare for the cancelled sector.
- The passenger can choose the lowest available (or passenger's) cabin over arrangement. Not valid in other respective RSR along with available non-refundable, if any.
- No No-refundable or Cancellation fee applicable as refund ticket.
