1. RDRs are based on IATA fare to \$10,000. RDRs are based on August 2018 market for international. For international flights the basic fare for RDRs is plus fare change fee. RDRs are based on the lowest available fare. Change is made in good faith.

**Note:**

- 1. Advance changes are applicable per person. In case of "non-refundable", basic fare will be refunded.
- 2. In case of the lowest applicable change and difference of fare is applicable.
- 3. Government taxes, RDRs will not apply for change/cancellation of flight.
- 4. In case of flight cancellation.
- 5. Advance changes are made by the airline. No refund.
- 6. Passengers are liable to the point of origin by the first available carrier. Full amount to be refunded.
- 7. Other arrangements for the cancelled tickets are made by the passenger. Refund of basic fare to the destination.
- 8. The percentage is not taken for the ticket cancellation at passenger's request. Full amount to be refunded to respective RDR along with cancelled non-refundable, if any.
- 9. No per-destination cancellation fees applicable on refund.
- 10. Taxes are based on original booking price.
