In terms of CAT issued by IATA for use on 30/09/2020 and effective 01/08/2020 onwards, the cancellation charges shall be made that the basic fare plus fuel charge (in addition to any discounts unless fuel charges are being regulated or waived).

Notes

1. Taxes/charges are applicable per person in case of non-refundable fares that are fully booked.
2. In case of the flexible applicable charges and difference of fare if any are applicable.
3. Cancellation Fees: MEC will apply for change cancellations/fuel difference.
4. In case of flight changes.
5. Alternative arrangements are made by the Airline - Not Refund.
6. Passenger is taken back to the point of origin by the first available service - Not refund to be offered.
7. Once arrangements for the cancelled sector is made by the passenger(s), refund of basic fare for the cancelled sector.
8. The passenger is not taken to the alternate destination as per paragraph 6 unless seen as arrangement - Not refund in order to replicate MEC along with standard non-refundable fares, if any.
9. In the continuation of cancellations the applicable charges apply.
