

## Amendment No- 2

With reference to the pre-bid meeting held at Alliance Bhawan, Dated: 08.03.2022. Following amendments are required to be incorporated in Catering Tender Ref No: AAAL/DEL/2022/1099.

S.NO	TENDER CLAUSE/QUERIES	AMENDMENT TO BE INCORPORATED
1.	Query	There will be no price escalation in the tender for 03 years.
2.	Part B, 26 (iv) , Page No : 20	Dry Stores : Dry store items will be uplifted in fixed / standard quantity as advised by the airlines and the payment will be made accordingly. TOB clause doesn't stand for dry store items.
3.	Part B, 26 (vii) , Page No : 20	Credit Period : As per MMAO – 715 Clause no 45.4, the payment terms will be 45 days for all MSME's.
4.	Part B, 17 (i) , Page No : 15	Security Deposit : As per MMAO -715 , Clause No : 22.7 , MSME SD/BG can be taken on yearly basis , renewal every year , the second year SD/BG should be valid till 60 days beyond the contract period or warranty period.
5	Part B, 29 (I) , Page No : 21	Meal bank is Valid only for the passengers of Special Flights/Inaugural Flights /Charter flights etc, not applicable for crew meals. Standby crew meals will be charged against the total meals utilized in the flight.
6	Part A, 2( vi) , Page No :6	Station wise Approx turnover is required as per the station mentioned in the clause (Certified Audited copies are required for 03 years), Profitability of the company is not considered during participation in the tender process.
7	Query	Separate bidding for each station/location is required to be made as per the tender document.
8	Annexure- 5,(1.21) , Page No : 33	Promotional material will not be a regular feature and shall be rarely required by the airlines. Same will be made without any additional charges by the successful bidder.
9	Part B, 31 (iv) , Page No : 22	It is required to have the freezer facility with the caterer for chilling and keeping the items as desired by airlines from time to time.
10	Annexure 3 (B)	Handling Charges: Charges will be inclusive of Storage / Chilling of items provided by the caterer / airlines.
11	Part B, 25 (vi) , Page no : 18	In case of any complaint and <b>found valid</b> which is received from the passengers of the flights or from crew of the flight regarding quality /quantity of meals , no payment will be made for the entire uplift of subject item/meal of the affected flight.
12	Annexure- 5,(1.20) , Page No : 33	The caterer shall provide the nutritional and calorific value of each menu item provided to the Airline at the time of scheduled change of menu if required.
13.	Annexure- 5,(3.2- i) , Page No : 34	The caterer shall also provide a Catering Van /Hi Lift/Station Wagon to transport such of the equipment or food items / dry store items , etc as may become necessary to be carried separately or in the last minute for increases at agreed rates only when the requirement is solely due to AAAL.
14	Annexure -10, Page no : 46	Bid Security Declaration form: It is in the place of EMD which used to be taken in the form of Bank draft . EMD used to be forfeited only when vendor backs out at any stage of tender or post award of contract as specified in the form.
