It operates International and mainly domestic commercial routes including the specific government's Regional Connectivity Scheme(RCS) Routes, Viability Gap Funding(VGF) Routes and as well as Commercial Routes. ALLIANCE AIR Aviation Limited has a young fleet of 18 ATR72-600, 2 ATR42-600 & 1 Dornier Do-228 aircraft. ALLIANCE AIR Aviation Limited currently connects 56 destinations within India and 1 international destination from Chennai to Jaffna in Sri Lanka with 120 plus departures per day.

- A minimum of 10 years of experience in airline network planning, route optimization, or related roles.
 Exposure to working as a Network Planning Consultant with Indian domestic airlines with also exposure to Tier II and Tier III cities.
- Familiarity with network planning software tools and data visualization platforms. In-depth knowledge of various aircraft types, performance metrics, and their suitability for different routes.
- Effective verbal and written communication skills for presenting findings, recommendations, and insights
- Positive references from clients in the aviation industry.

11.0 Evaluation Criteria and Method of Evaluation:

- Screening of EOIs shall be carried out as per eligibility conditions mentioned in this document and based on verification of testimonials submitted.
- EOI will be evaluated for short listing inter alia based on their past experience of handling similar type of project, strength of their man power, financial strength of firm and presentation / proposal to the Alliance Air whose decision will befinal.

ANNEXURE 1

TERMS OF REFERENCE

The scope of Network Planning Consultant responsibilities to include:

- <u>A.</u> <u>Current Flight Schedule:</u> Analyze the current flight schedule. Present a clear list of recommended route additions, reductions, temporary and permanent suspensions, closure of stations along with explanations for each recommendation.
- B. Proposed Flight Schedule: To draw up a flight schedule taking into note:
- i. Different aircraft types (ATR 72-600, ATR -42-600 and D-228) with the seat and cargo capacity available per aircraft between different O & D Points
- ii. Current slot availability. Engineering maintenance pattern, Catering and Ground Handling availability. Crew availability including FDTL etc. and minimization of layovers.
- iii. Prioritize schedules that facilitate seamless connections. Projected Passenger demand on the respective city pair taking into note the seasonal travel demand fluctuations. Historical records of flight performance and its route economics and forecasted passenger demand. Competitive landscape.
- iv. Subsisting and proposed VGF and RCS Agreement / Flights. RCS slots abandoned by other airlines
- v. Positioning of aircraft at different stations. Availability of night parking slots. Navigational aids / watch hours VFR airports Turnaround time at each airport, gate availability, parking stands, taxi times and peak travel times.
- <u>C.</u> <u>New Routes:</u> To propose new routes based on a comprehensive financial analysis of factoring in costs (Meeting ATF, Operational, EBIT, EBITAR and Total Cost), revenues, breakeven points, availability of crew, availability of slots, likelihood of disruptions as also ROI within a specified timeframe.
- <u>D.</u> <u>Exploring Code share:</u> Identify code-share and partnering prospects to broaden network coverage and expand destination offerings.
