1. Alliance Air Aviation Limited under the two bid system invites 'Technical' & 'Commercial' Bids from authorized fuel suppliers for Supply of Jet A1 Fuel (ATF) at various Indian airports as per the details given hereunder. This tender includes the Fuel requirements of the **customer airline** i.e. ALLIANCE AIR AVIATION LIMITED (Brand name Alliance Air, call sign 9I, wholly owned subsidiary of AI Asset Holding Limited)
2. Sealed bids should be submitted in **two** separate envelopes superscripted as '**TECHNICAL**' AND '**COMMERCIAL**', as the case may be, and quoting our Tender No. **AAAL/ENGG/ED-25/102**. The bids should be submitted by 15:00 hrs on 14th May 2025. The Technical bids should cover all the details including those given in **Para 7** of this tender document and provide all the required supporting documents.
3. If there are any deviations to non-mandatory conditions, bidders are required to specify these at Appendix-D of the Technical bid. In case both Technical & Commercial bids are submitted to the office of MMD, **Alliance Air Aviation Limited**, Terminal 1-Alliance Bhawan, New Delhi- 110037, in one single envelop, the bids will be rejected. However, two separate sealed envelopes containing Technical and Commercial bids in their respective sealed envelopes to be kept in one covering envelope.
4. Bidders desiring to be present at the time of opening the technical bids and upon being evaluated qualified under Technical bid evaluation, the financial bids, of the technically qualified bidder will be opened and on the day of opening of the Financial bid, the representatives of the qualified bidder may also present with the valid authority of the bidder. Technical bids will be opened at the office of Materials Management Department, **Alliance Air Aviation Limited**, Terminal 1-Alliance Bhawan, New Delhi-110037.
5. Commercial bids will be opened of only those parties whose Technical bids are found to be acceptable after evaluation by **Alliance Air Aviation Limited**, which will be carried out based on the evaluation criteria given in this tender and the Technical bid details. Parties whose technical bids are found acceptable would be informed of the date, time and venue of opening of the Commercial (Financial) bid.

1. FLEET DATA:

Alliance Air Aviation Limited has a wide range of fleet numbering over 18 ATR 72 and 2 ATR 42 & 1 Dornier. Following are the types of aircraft that are presently in the AAAL fleet.

1. **ATR72 -Current**
2. **ATR42- Current**
3. **Dornier-Current.**

Additional aircraft if any required shall also be covered based on prior written intimation to the refueler during the currency of the contract.

2. PERIOD

The contract period will be from 1st Jun 2025 to 31st May 2028 (Three years). The contract can be extended at the same terms and conditions by Alliance Air Aviation Limited for a further period up to one year by informing the suppliers at least three months prior to the expiry of the contract.

3. LOCATIONS

- 3.1 Details of stations where ATF supplies would be required presently indicated as per enclosed **Appendix "A"**. Alliance Air Aviation Limited requirements for ATF supplies at the indicative locations would depend upon various operational factors and requirements; as such AAAL does not guarantee upliftment at these locations nor guarantee any volume therefrom.
- 3.2 Further, AAAL reserves right to amend award in respect of changes for AAAL locations such as add/withdraw locations/stations, add/delete flights at the awarded locations/share-outs, add/change type of ATF upliftment (bonded/duty paid), consequent increase/decrease station-wise allocations/share outs, and such other related requirements in the best overall interest of the AAAL group.
- 3.3 For inclusion of any new Station, reasonable notice would be sent to the selected supplier by the AAAL for resource mobilization. Such arrangement to be confirmed by AAAL in writing and acknowledgement of which by the selected supplier would constitute amendment to the award/agreement.

4. FUEL SPECIFICATIONS

Kerosene type jet fuel: Jet A-1 meeting the Aviation Fuel Quality Requirements for Jointly Operated Systems "Joint Fuelling Systems Check List", which by definition also meets the following specifications for Jet A-1: British Ministry of Defense DEF STAN 91/91, ASTM D 1655, IATA Guidance Material for Kerosene type fuel.

5. QUANTITY

- 5.1 The estimated forecast fuel requirements on annualized basis in Kiloliters (KLs) for the airport locations listed in paragraph 3 are indicated separately for Duty paid requirement against each station in **Appendix "A"**.
- 5.2 Quantity/Uplifts indicated in Appendix "A" are based on the current pattern of flight operations. Details reflected in Appendix "A" are to be considered as indicative only for the limited purpose of tender evaluation and award of share-outs/allocations for indicated locations.
- 5.3 Actual Quantity uplifted during the contract period shall vary based on revised pattern of flight operations and the company requirements. In the case of locations having more than one supplier allocated quantity based % shares, such suppliers shall among themselves through the periodic pool meetings at such stations adjust the volume of upliftment inter-se to ensure adherence to the % share out awarded. However, the operating AAAL will endeavor to provide to the selected awarded bidders at the respective locations the estimated fuel uplifts at each location for periodic flight time table change filing done with DGCA during the contract period, which is generally during March and October, every year.
- 5.4 Quantity/Uplifts indicated in Appendix "A" are the annualized forecast requirements for ALLIANCE AIR AVIATION LIMITED (Brand name Alliance Air, call sign 9I), a wholly owned subsidiary of AI Asset Holding Ltd).
- 5.5 The requirements of ATF covers not only the scheduled flights of all the above companies but also covers all the presently operated extra section flights, VVIP operations, non-scheduled flights, Chartered flights, practice and test flights and uplifts for maintenance, and test cell facilities. Any changes upon introduction of new/additional locations/flights, the allocations would be evaluated and awarded in terms of the Para 3 above read with the evaluation criteria at Para 9 and share-out terms at Para 10.2 below.

5.6 The tender is not for a fixed volume, there being no minimum guarantee of fuel up-liftments at any station.

6. DELIVERIES

6.1 Delivery of fuel shall be effected to ensure the departure timings of flights at respective airports.

6.2 At those stations where qualified personnel of Alliance Air Aviation Limited are not available to carry out the quality control and refueling procedures, the fuel supplier shall use the Alliance Air Aviation Limited quality control and refueling procedures. These procedures, as and when required, will be given at the time of award of the fuel contracts.

6.3 Alliance Air Aviation Limited shall have the right to determine the specific gravity of a sample from any particular fuelling, which will be selected at random.

6.4 Invoicing

- i. Refuelers shall provide three copies of the delivery receipt/challan in respect of each fuel upliftment at the time of delivery specifying complete customary details, such as customer airline name, flight number, aircraft registration, type of aircraft, specific gravity factor, the quantity of the fuel delivered and accepted (signed) by the representatives of both Alliance Air Aviation Limited and the refueler, whose identity (name and designation) indicated thereon.
- ii. One Original of such delivery receipt in respect of each upliftment to be attached and sent along with the original periodic invoice for each location.
- iii. Such Original invoice to have a summarized list of all the delivery challans of the relevant period.
- iv. Each invoice should have all the required invoicing details including the type of fuel supplied (duty paid), the basic price, the discount applied, each element of applicable tax/duty/statutory levy applied with nomenclature & code with % and amount etc.
- v. No Photocopy of Delivery receipt shall be entertained for accounting or for making payment.

7. TECHNICAL BID (Should Be submitted in a separate envelop)

7.1 The Technical Bid must be submitted in the format as given in **Appendix "B"** along-with duly filled details as per the **Appendix "C" and "D"** in a separate envelope superscripting, the '**Tender No: AAAL/ENGG/ED-25/102-Technical Bid**' on the envelope.

7.2 The technical bid should contain the following details:

- i. At the time of bidding, bidders submitting offers should be authorized fuel suppliers and having arrangements with the Into-plane services providers (IOSP), where-ever such requirement of IOSP exist, and who are licensed by the conged Airport and/ or appropriate regulatory authorities. In support, bidders to attach relevant documents like Approvals / Licences received from the conged authorities, or an agreement signed with such Authorities for supply of fuel at airports which have been subject to bid.
- ii. Type of fuel that can be supplied (e.g. JET A1) at the stations listed in Appendix 'A'.
- iii. If refueling is through bowser, bidder is required to specify if there are any capacity constraints by indicating the number of bowsers with their capacity for such locations.

7.3 List of airlines served by the bidder at each of the cities given in Appendix "A". Bidder is requested to furnish the details Airport-wise.

7.4 Indicate quantity (in KLs) and also in percentage terms of the total projected quantity, that bidder would be able to meet with at the locations mentioned in Appendix 'A'. For example: AMD - 100% of the quantity mentioned in Appendix, HYD – 50% of the quantity mentioned in Appendix. Additionally, bidder has to indicate the fuel quantity (in KL) against each location at Appendix-A for which they have submitted their bid.

7.5 The Technical Bid should thus consist of the following:

- i. Duly filled, signed and stamped **Appendix-B** form with the required supporting documents
- ii. Bidder's Profile as per **Appendix-C** on bidder's letter head.
- iii. Letter of Authority on applicant's letter head from Authorized Signatory of the applicant to sign and submit the bid / proposal.
- iv. Certificate of Undertaking and Compliances as per **Appendix-D** on applicant's / bidder's letter head including

acknowledgement to execute and supply fuel for requirements as per this tender and commit to provide the required Deliverables and comply with all the Technical Specifications and Deliverables.

8. COMMERCIAL BID (FINANCIAL BID) – In a separate sealed Envelope

8.1 Commercial bid of only those bidders who are found to be technically qualified on the basis of the technical bids will be opened.

8.2 Commercial (Financial) bid is required to be submitted in the format as given in **Appendix “E”**.

8.3 Commercial bid must be submitted in a separate sealed envelope superscripting the ‘**Tender No: AAAL/ENGG/ED-25/102 -Commercial Bid**’ on the envelope.

8.4 The Commercial bid must contain the following information on Price Quotations:

- a) Based on the above information, please submit your lowest quotation (separately for Bonded Fuel in USC/USG and Domestic Duty Paid in Rs./Kilolitre for each location) as per format given in Appendix “E” for into-plane supply.
- b) Basic rate comprise of price based on benchmark such as Mean of Published Platts Arab Gulf (MoPAG) quotation of relevant area on a monthly basis. The conversion of the USD quotes into INR would be on the basis of the RBI Reference rate for the period for which the quote pertains. This basis of conversion will be used throughout the contract period.
- c) Charges added to the basic fuel prices upto the delivery point of the aircraft are required to be indicated with each head of charge, such as Into Plane services charges, Through-put fees, etc.for the locations where-ever such charges are applicable.
- d) In case the MOPAG benchmarked pricing details are not offered, the bidder to indicate in the sealed financial bid the Published Airfield Prices (PAP) based prices for each quoted station.
- e) There should be complete transparency in pricing the final product i.e. ATF.
- f) Indicate discount / add-on offered on basic rate for each location. The discounts / add-ons must be the best being offered to any other Airline/ Operator at the respective airport at the time of submission of the Commercial bid.
- g) Any additional discount offered location wise on Regional Connectivity Routes (RCS) under “ UDAN “ Scheme or Special Exempted Routes like North East along with other Tax/ Incentive benefits needs to be mentioned separately.
- h) Price reviews for Duty paid and Bonded fuel should be on a monthly basis or as may be applicable as per the Govt. guidelines in this regard.
- i) Indicate Interest free credit period (**in no.of days**). No bank Guarantee will be offered by Alliance Air Aviation Limited.
- j) All rates of duties & taxes, including VAT, Entry Tax, Cesses applicable to fuel for each airport must be mentioned in the Commercial (Financial) bid itself.
- k) Basis of valuation for levying the applicable taxes would be basic price of fuel at delivery point less the offered quoted discounts or Add-on. Any deviation in the valuation formulae to be indicated with tenable justification in support requiring such deviant valuation methodology/basis.
- l) In the event of changes in future during the contract period in the structuring of the pricing for some elements, such as Into plane, throughput services and the changes in tax structure/basis such as GST applicability on ATF, the selected bidders should undertake to pass on the benefit of such changes to the customer airlines and provide their invoicing and supporting documentation accordingly as may be mandated/required.
- m) The Invoices are to be generated as detailed at Para 6.4 above and submitted to designated customer airlines offices for fuel supplies at each location at 15 day period interval basis. All such tax invoices with the delivery supporting documents should be sent to AAAL. A summary of the invoices reflected in a cover letter be forwarded to the designated email ids of the customer airlines of AAAL in advance pending receipt of the hard copy of the invoices and the delivery challans. Separate Invoices shall be generated for AAAL (9I) coded flights which will be submitted to the respective designated offices.
- n) The bids must be valid for a minimum period of 180 days from the closing date of technical bid submission.
- o) Acceptable conversion factors for USG/MT, USG/BBL & KL/BBL are to be maintained at 331 USG = 1 MT, 42 USG = 1 BBL & 1KL= 6.2898 BBL.
- p) The prices offered (post-discount or add-on) should be location-wise.

9. EVALUATION PROCESS AND SELECTION CRITERIA

9.1 Technical Bids Evaluation :

- i. The Technical Bids will be evaluated for their compliances to the requirements indicated at
 1. Para 7 above,
 2. The terms stated at Appendix B , and
 3. General Terms and conditions (para 10 below)
- ii. All the requirements and specifications mentioned in the **Appendix B** are mandatory and bidders not meeting any one of these requirements would be rejected.
- iii. Alliance Air Aviation Limited reserves the right at its sole discretion to seek clarifications, information, documents, etc. from the bidders, as it may consider necessary for the purpose of evaluation of the bids. Bidders should respond to such requests within the time frame indicated.
- iv. Additionally, bidders may note that:
 - a) Any exception to the mandatory requirements will lead to rejection of the Technical Bid.
 - b) As a part of this evaluation process, the bidder's client's sites and/or offices of bidders may be physically inspected to ascertain the claimed capabilities of bidder.
 - c) Bidders whose claims/supporting documents filed are found not complying with the stipulated tender requirements could be technically disqualified at any stage.

9.2 Financial Bids Evaluation

- a) The date and time of opening of the Financial Bids would be intimated in advance by email/ phone to the bidders who have qualified, and their authorized representatives only would be permitted to participate in the opening of the Financial Bids.
- b) The Financial Bids of only those applicants/bidders, who qualify and are shortlisted after complete technical evaluation of their Technical Bids, would be opened.
- c) Alliance Air Aviation Limited will evaluate the bids station-wise and also on the overall to determine the lowest bidders to the maximum advantage to Alliance Air Aviation Limited considering the share- outs, if applicable.
- d) For the purpose of evaluation of MOPAG based USD price bids, the average of the quoted Prices and RBI Reference Rate for the period 1st March 25 to 31st March 25 will be taken for converting the figures to Indian rupees for financial bid evaluation.
- e) The interest free credit period would be evaluated at an interest rate of 1% per month and credit/loading for evaluation purposes would be given accordingly to the bidder.
- f) The bids will be evaluated for each location based on the prices quoted/converted in Indian Rupee net of the offered discounts at respective location, the applicable taxes/duties added and the loading/unloading applied, where-ever required as per the tender terms.
- g) The bidders providing the MOPAG quotes and the differential thereon to also quote the maximum offered discount on the applicable PAP for the location and for the volume offered. For the purpose of financial bid evaluation and comparatives, the INR maximum offered discounts on the PAP would be used for selecting the bidder (s).
- h) The best offers as evaluated would be allocated share-outs as per terms indicated at Para 10.2 below.

10. GENERAL TERMS & CONDITIONS

10.1 The bidders must submit unconditional bid.

10.2 Share-outs – Alliance Air Aviation Limited will decide on the share outs of the various bidders on the evaluation of the Prices quoted and the capacity of the bidder at the particular airport and such decision will be final and binding. The decision of Alliance Air Aviation Limited on Share outs at each location will be based on evaluation of prices quoted, the rate of discount offered on basic price and the bidders existing capacities to the maximum advantage of Alliance Air Aviation Limited. **Bidders will have to confirm that they will adhere to the share outs decided by Alliance Air Aviation Limited throughout the**

contract period. The Bidder may be called for discussions / negotiations.

- 10.3 Alliance Air Aviation Limited does not hold any responsibility whatsoever with regard to loss of response of a bidder to the tender document, delays due to postal/ courier deliveries.
- 10.4 The bids will be evaluated for each city based on the price quotes. In case of the USD quoted prices, the average of the Price and RBI Reference Rate for the period 1st March 25 to 31st March 25 will be taken for the purpose of evaluations.
- 10.5 Alliance Air Aviation Limited reserves the right to accept / reject any bid or to award part or full business to one or more suppliers, without assigning any reason thereof.
- 10.6 **Bidder's quotation will be rejected on the following grounds:**
- In case of only Technical bid received and commercial (Financial) bid not received and vice versa.
 - In case of bids are received in open envelop.
 - In case the bids received through E- mail **with Out** Password protected. The Password will be shared only to the authorized committee members at the time of opening of Bids.
 - In case both the Technical & Commercial (Financial) bids are sent in one sealed envelope instead of two separate sealed envelopes. However two separate envelopes can be kept in one covering sealed envelope.
- 10.7 When deemed necessary, Alliance Air Aviation Limited may seek clarification on any respect from the tenderer after opening of the Technical Bid for the purposes of technical bid evaluation and the bidders are expected to promptly provide the required information, details and documents in their own interest.
- 10.8 Alliance Air Aviation Limited reserves the right to waive off the requirements of submission documentary proof for eligibility criteria at its sole discretion if it is satisfied with the tenderer's credentials which Alliance Air Aviation Limited may check from reliable sources.
- 10.9 If the tender closing/opening date is declared a Holiday in Alliance Air Aviation Limited, Delhi Office, the last date of submission/ opening of the bids will automatically stand extended to 12 hrs / 15 hrs respectively of the next working day.
- 10.10 **Agreement Clauses:**
The following are some of the clauses/details which are required to be incorporated in the Agreement with the selected fuel supplier.
- i) Format:** Agreement between Alliance Air and selected fuel supplier shall be as per the IATA model agreement.
- ii) Addresses:** Alliance Air Aviation Limited is having its registered office and principal place of business as follows:

- iii) Payment Terms:** Payments would be affected on the 15 days invoicing cycle after availing the interest free credit period offered by the bidder in the commercial bid **In Indian rupees** only. For the purpose of conversion (in case bonded supply) from USD to INR RBI reference rate of the date of supply shall be taken.
- iv) Termination/Exit clause:** Termination for any reason shall be without prejudice to any right or obligations of the party which have accrued prior to termination
- 1) Alliance Air Aviation Limited reserves its right to terminate the contract in the event of unsatisfactory performance by the service provider by giving a maximum of 30 days' notice.
 - 2) Alliance Air Aviation Limited reserves its right to amend the schedule of operations for any particular station due to change in its requirements. The party would be suitably informed.
 - 3) For any other reasons, the contract can be terminated by either of the parties by giving 60 days' notice.
- v) Penalty clause:** Penalty will be levied to the refueler on account of any delays / cancellation to our

flights due to no refueling even though scheduled or ordered or delayed refueling or denial of such required re-fuelling facility.

- a. The designated scheduled refueler will have to bear the additional price differential if alternate arrangements were made by Alliance Air Aviation Limited against non-delivery/ delayed deliveries, in addition to paying the applicable penalties.
- b. Apart from this there will be a penalty of 1% of the cost of the fuel uplift for that flight.
- c. Furthermore, in case Alliance Air Aviation Limited suffers any losses on account of Share outs not maintained, the same will be recovered from the party not maintaining their part of the share out.

vi) Governing Laws, Disputes and Arbitration clause:

- a. Any dispute arising between the parties in respect of the construction, interpretation, application, meaning, scope, operation or effect of this TENDER and/or the contract or the validity or breach thereof, shall first be settled by mutual consultation. Any unresolved dispute whatsoever shall be subject to the jurisdiction of Delhi (India) Courts only In case of any disputes, the arbitration rules of Indian Council of Arbitration shall be applicable.
- b. All the disputes and differences arising out of or in any way touching or concerning the Agreements with the selected CPSE bidder shall be resolved through the mechanism of arbitration in terms of the **Arbitration clause** as per the Government of India Notification REF No. F.No.4 (1)/2013-DPE(GM)/FTS-1835 dtd 22nd May, 2018 for settlement of commercial disputes between Central Public Sector Enterprises (CPSEs) inter se and CPSE(s) and Government Department(s) / Organization (s) - Administrative Mechanism for Resolution of CPSEs Disputes (AMRCD).

vii) Force Majeure
